

### **Increase in Issued and Paid-up Share Capital of Wholly-owned Subsidiary**

The Board of Directors of Captii Limited (the “Company”) wishes to announce that its wholly-owned subsidiary, Unified Assets Sdn Bhd (“UASB”), has increased its issued and paid-up share capital from RM100.00 to RM1,000,000.00 by the allotment and issuance of 999,900 ordinary shares at RM1.00 per share.

The increase in share capital was funded through internal resources and is not expected to have any material effect on the net assets and earnings per share of the Group for the financial year ending 31 December 2018.
